
Sub-Sanction of 100 KVA H.T. power at 653 654 1 PH 9 Khata No 297 Rangwasa Road Rau Indore 452001

Dear Sir/Madam,

We are in receipt of new H.T. application form along with registration fee of Rs10000/- on dated 2018-01-06(ONLINE/OFFLINE PAYMENT) vide which you have applied for a H.T. connection to the extent of 100kVA, for the purpose of For Non Industrial Purpose at 653 654 1 PH 9 Khata No 297 Rangwasa Road Rau Indore 452001

However, your request has been conditionally considered and provisional sanction is hereby accorded for sanction of 100 KVA subject to the following conditions:-

- You will have to submit all the requisite documents as mentioned above within a period of 15 days from the receipt of this sanction letter.
- As per "M.P. Electricity Supply Code 2013, you shall be responsible for providing "right of way" wherever necessary for laying of lines and also for easy and independent access to the metering point.
- You will have to obtain necessary approval/permission of the local/statutory authority, if required under any law/statute for manufacturing of above product before the commencement of supply and also to observe all the conditions specified therein. In case of failure to do so, the West Discom will absolve from the all liabilities that may arise on this account.
- In the event of any dispute raise related to authenticity of documents submitted by you as per M.P. Electricity Supply Code'2013 for availing H.T. supply or if any dues found outstanding on the premises for which connection applied for and against any firm /Company which is associated to your firm as Owner, Partner, Director or Managing Director, it shall be lawful for the West Discom to cancel the sanction / discontinue the supply of energy and during the period of disconnection, you will be liable to pay the demand charges /minimum charges etc.as per tariff order as in force from time to time till the currency period of HT agreement which will be executed by you with West Discom.
- You will have to get the work of extension of line, through an 'A' class contactor at your cost as per the estimates and layout approved by the West Discom within the stipulated timeframe as per M.P. Electricity Supply Code'2013 which will be intimated to you in due course after receipt of essential documents as mentioned above. The work will have to be as per sanctioned estimate and technical specification of the West Discom and you have to deposit 5% Supervision Charges with 12.36% service charges with Company before execution of HT agreement. On receipt of documents, the action for ascertaining technical feasibility of supply and deciding the point of supply/preparation of estimate will be initiated. After ascertaining technical

feasibility the quantum of line, extension work along with charges payable by you shall be communicated with cost of estimate & be provide draft agreement which shall be treated as final sanction letter.

h) If any line i.e. 33 KV/11 KV line / LT passing in your premises, the same has to be shifted before commencement of HT supply at your cost and if you refused to do so, this provisional sanction stands automatically cancelled without pre-judicious of any law.

i) You will have to observe regulatory measures.

It may kindly be noted that in case the requisite documents as listed above are not received within a period of 15 days from the date of receipt this letter, this provisional /conditionally sanction of HT power shall be treated as cancelled and thereafter the request shall be treated as fresh application and dealt with accordingly.
